**Court has finally approved a class-action settlement
regarding liposuction to treat lipedema**

**If you had a pre-serviced or post-service claim for
liposuction to treat lipedema (“Lipedema Surgery”) denied by Aetna Life Insurance Company as cosmetic, experimental or investigational between May 9, 2015 and September 1, 2020 you may be entitled to benefits from the settlement**

A court authorized this notice. You are not being sued. This is not a solicitation from a lawyer.

- This is the second notice sent to Class Members regarding the settlement of this case. The Court granted final approving of the Settlement on June 10, 2026.
- Persons who paid out-of-pocket for Lipedema Surgery after a cosmetic, experimental or investigational denial between May 9, 2015 and September 1, 2020, for surgeries that occurred prior to September 1, 2022 can submit a claim for reimbursement. Such persons are eligible for reimbursement to the extent their out-of-pocket payments were not paid by other insurance, Medicare, or other reimbursement sources for which the Class Members owe no reimbursement obligation.
- Persons who were denied Lipedema Surgery by Aetna during the same time period but have not yet undergone the surgery, and are current Aetna members, can submit their requests for approval for future surgery under the terms of their current Aetna Plan and Aetna’s new clinical policy bulletin which provides coverage for medically necessary Lipedema Surgery.
- Claim forms for submitting requests for reimbursement are included with this notice, and can also be found at <http://www.LipedemaSurgerySettlement.com>.
- Class Members have until [insert date] to submit their reimbursement requests.
